Latin Can Be Greek To Some

As you may be aware others are often given permission to act as an agent. An agent alleged of committing a tort could trigger cause of action against the principal to be held liable for the tort the agent committed. This is known as the doctrine of *respondeat superior* ("let the master answer").

According to Agency Law, the doctrine provides for vicarious liability to a principal for the torts of an agent when:

- 1) the agent is an employee of the principal
- 2) the tort was committed while in the course and scope of the agents employment.

Determining if an agent is an employee or independent contractor may not be as challenging as determining if the agent was in the course and scope of employment when the tort was committed.

If the agent is an employee, the principal and the agent may have joint and several liability for the tort committed and an injured third party may file complaint against the principal, the agent, or both for recovery of damages sustained. But that challenging topic is for another corner, another day.




