ACA ANNUAL GOLF OUTING 2019

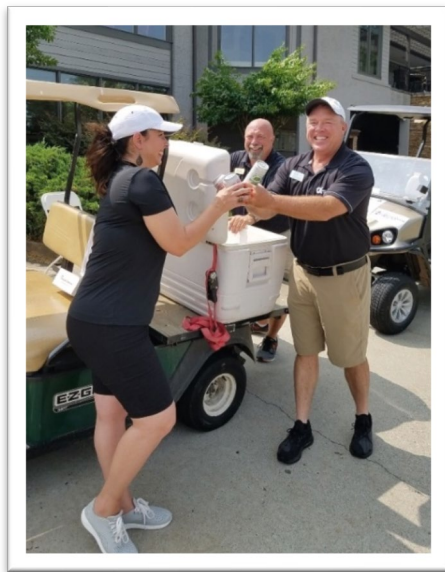
